
My Seven-Year Investigation into Warren Jeffs and the Fundamentalist Church of Jesus Christ of Latter-day Saints





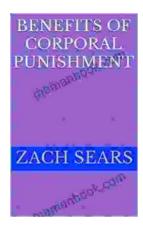
